## Description

A single level field parcel of 10.39 acres (4.2 Ha), east of the village of Hambridge. The field is currently laid to permanent pasture, recently being used for the grazing of livestock and hay making in recent years. The land is bounded by a mixture of natural hedgerows and ryne. The land has potential for a number of end uses including agricultural, amenity and equestrian (subject to the necessary consents).

The land lies off Westmoor Lane/New Road inbetween Hambridge and Stembridge, benefiting from direct road frontage.

#### Directions

Travelling from Langport, head south-east on the A378 towards Curry Rivel for approximately 2 miles. Once at Curry Rivel, head towards Hambridge through Willtown, for approximately 2.5 miles. On arrival at Hambridge take the left opposite the Lamb & Lion, along Westmoor Lane which will become New Road. Continue along this road for about half a mile, the field will be on your left hand side, identified by a Tamlyns For Sale board.

#### Services

There are no mains water supply to the land.

#### Tenure

The land is currently subject to a grazing licence agreement, running from 1st April 2020 - 31st October 2020. If completion is prior to this date, occupation will not be available until 1st April 2020.


